IMPORTANT LOAN INFORMATION

In order to comply with the Credit Card Act of 2009, Parish Credit Union has made a change to some loan due dates on members' accounts. Due dates on open-end loans have been advanced and will now be due at the end of each month. If you prefer to pay your loan at another time during the month, prior to the end-of-month due date, you are still welcome to do so. If you requested an automatic payment transfer, the automatic payment will continue to process according to the most recent instructions the credit union has.

Open-end loans will now receive a monthly statement.
